Elm Ridge Exploration Co LLC has drilled a 7 7/8" hole to a TD of 7190' as of 12-24-11. On 12-27-11 172 joints of 5 1/2" 15.5" J55 casing was set at 7153'.

First stage: Lead with 110 sks Halliburton Premium cement. Tailed with 330 sks 50/50 POZ cement and circulated 10 bbls good cement to surface.

Second stage: Lead with 780 sks Halliburton Premium cement. Tailed with 50' sks Premium Class G cement and circulated 81 bbls good cement to surface. Used a total of 1270 sks of cement. DV tool set at 4661'.

Pressure tested well to 2000 PSI for 30 plus minutes. Test was good. Moved rig off location on 12-28-11.
