Envirotech, Inc. has completed spill assessment activities at the Krause WN Federal #4E well site located in Section 33, Township 28N, Range 11W, San Juan County, New Mexico.

Envirotech, Inc. arrived on-site on October 4, 2010, to assess a spill of an unknown amount of produced water from a leaking above ground storage tank (AST) at the above referenced location. Upon Envirotech's arrival, a brief site assessment was conducted and the regulatory standards for the site were determined to be 100 parts per million (ppm) total petroleum hydrocarbons (TPH) and 100 ppm organic vapors, pursuant to New Mexico Oil Conservation Division (NMOCD) Guidelines for Remediation of Leaks, Spills, and Releases due to the well site being less than 200 feet from surface water.

One (1) surface composite sample was collected from the visually stained area of approximately 28 feet by 25 feet next to the AST; see attached *Field Notes* for sample location. The sample was analyzed in the field for TPH using USEPA Method 418.1 and for organic vapors using a photoionization detector (PID). The sample returned results of non-detect (ND) for organic vapors, but above the regulatory standard for TPH; see attached *Analytical Results*. The sample was then collected into a four (4)-ounce glass jar, capped headspace free, and transported on ice, via chain of custody, to Envirotech's Analytical Laboratory to be analyzed for TPH using USEPA Method 8015. The sample returned results of ND for TPH; see attached *Analytical Results*. Envirotech, Inc recommends no further action in regards to this incident.
