JAECO spudded the subject well @ 9.15 AM, 3/29/2012. Mo-Te Rig 212 air drilled a 12 1/4" hole to 319' GL. Mo-Te ran 9 5/8" 36# J55 STC csg as follows: Sawtooth Collar, 1 jt csg, insert float, 14 jts csg for a total of 316' casing, set at 314' GL with insert float at 291' GL; centralized 1st, 3rd, and 5th joints csg. Mo-Te cemented casing using: 10 bbls pre flush + 6 cu yds, 162 cf, Type 1-2 14.5 ppg redi-mix cement followed by wiper plug, 22.5 bbls fresh water. Plug down @ 11:30 am, 3/30/2012; checked float - held; Circ 8 bbls, ~45cf, cement to surface. Cement job witnessed by Rod Velerde, JAOGA; Rig down move out Mo Te Rig 212. 3/31/2012: set cellar, weld on 9 5/8" csg head, test weld to 1200 psi. 4/4/2012: WellCheck pressure tested csg-hd/9 5/8" csg to 600 psig for 30 minutes - held. Present well status - waiting on drilling rig.
