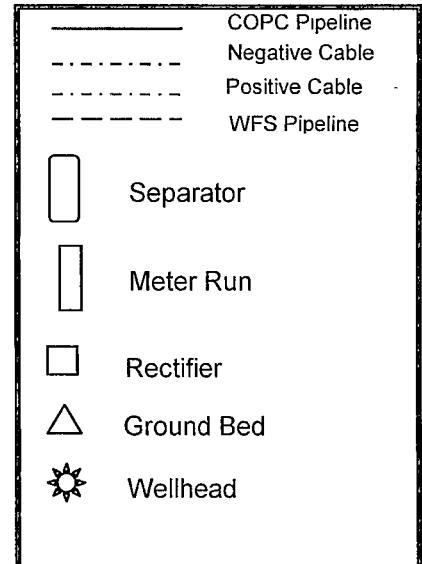
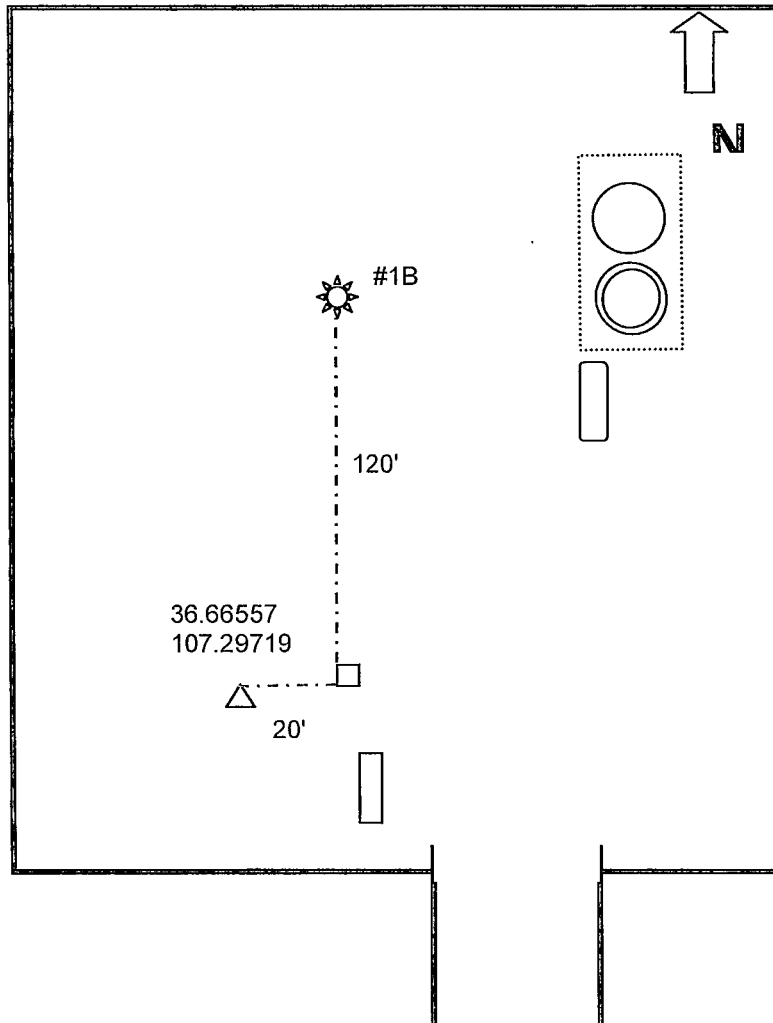

Drill ground bed approximately 120' south of #1B wellhead at staked location. Install single-well solar unit and install cables to new ground bed and #1B wellhead at lengths below.
