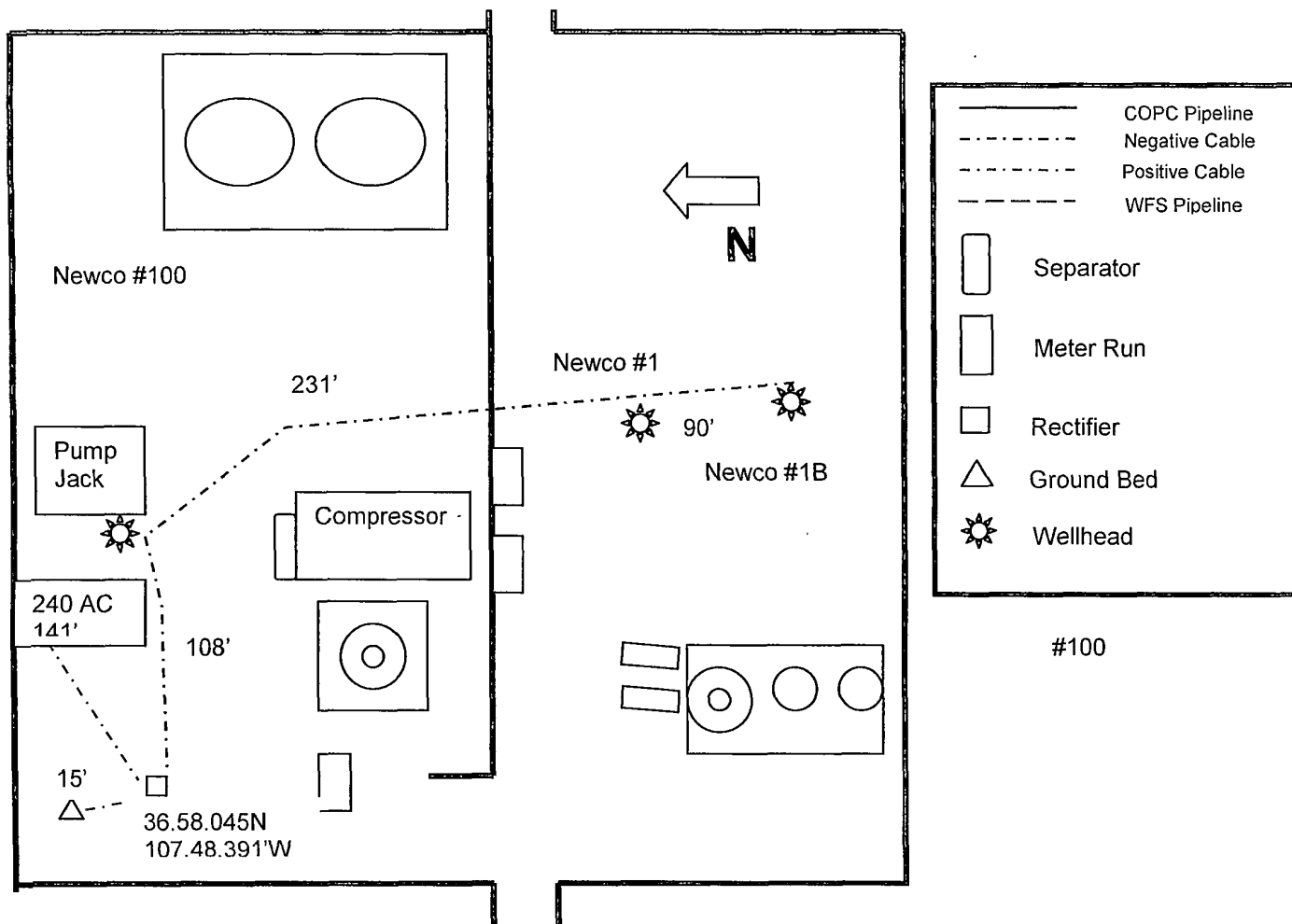

Install 40-16 rectifier at staked location and connect to existing UGAC at pump master control panel. Install cable to new ground bed and to Newco #100, #1 and #1B wellheads at lengths below.
