Attached are Form C-102 plats for the following-described wells in the Blanco-Mesaverde Gas Pool:

Jicarilla Contract 155 No. 30 (API #30-039-22570) 1120' FNL & 820' FWL (Unit D)
Jicarilla Contract 155 No. 34 (API #30-039-23412) 1060' FNL & 870' FEL (Unit A)
Jicarilla Contract 155 No. 16M (API #30-039-29995) 760' FNL & 2570' FWL (Unit C)

The Jicarilla Contract 155 No. 30 was originally drilled in 1980 by Amoco Production Company to test the Gonzales-Mesaverde Gas Pool. The well was dedicated to a standard 160-acre gas spacing unit comprising the NW/4 of Section 30. By Order No. R-7277 dated May 1, 1983 the Gonzales-Mesaverde Gas Pool was abolished and the Blanco-Mesaverde Gas Pool was extended to include Section 30. By NSP-1400 dated August 15, 1983, Amoco Production Company obtained Division authorization to keep the 160-acre non-standard gas spacing unit in place for this well.


The Jicarilla Contract 155 No. 34 was drilled in 1984 by Amoco Production Company to test the Blanco-Mesaverde Gas Pool and was dedicated to a 160-acre non-standard gas spacing unit comprising the NE/4 of Section 30. Although Enervest believes that this non-standard unit was approved by the Division, we have been unable to locate an applicable hearing or administrative order.

Enervest Operating, LLC ("Enervest") is the successor operator of the N/2 of Section 30. Enervest is proposing to drill the Jicarilla Contract 155 No. 16M in Unit C of Section 30 as a development well in the Blanco-Mesaverde Gas Pool. **Enervest proposes to change the acreage dedication for each of the above-described wells such that a standard 320-acre spacing unit comprising the N/2 of Section 30 will be established.** The interest ownership within the N/2 of Section 30 is common, and the proposed re-dedication of acreage will not cause any change in interest ownership between the wells. Consequently, correlative rights will be protected.
