Our investigation of production problems revealed that the basal Fruitland Coal is plugged and we are unable to pump into it. We ask for an additional 30 days to re-perforate the basal coal and test the well. Perforating is scheduled for Tuesday 5/1/2012. No new perforations are being added.
