The Trading Post 28 No. 1 well was returned to production on Friday April 20, 2012. The well is produced through the the Trading Post 27-1 gathering system. On the first day since it was returned to production it made 1 BWPD and the gas was to small to measure. With the low pressure gathering system now operating the dewatering of the Fruitland Coal seam well will proceed. The water producing rate will be monitored and it may be necessary to replace the downhole pump.
