Established an injection rate into the perfs with 24 bbls of water at 4 BPM and 500# Pumped 88 sx (103.8 cu.ft.) of CI "B" neat cement with 1/4 #/sk celloflake in the first 20 sx and 30 ball sealers. Final pressure was 800# There was cement to surface on the 7" X 4-1/2" annulus. Installed the P&A marker. Plan to clean the location ASAP.
