3/31/05 - The Dakota has been temporally abandoned under a CIBP at 5,485' to allow the recently recompleated Mesaverde to produce. The CIBP was tested to 1,025 psi. The well has been placed on line as a Mesaverde only producer and the Dakota will be brought back on once the Mesaverde has been depleted. Ownership of both zones are the same.
