- February 28, 2012:
  - Move in and Rig Up well service unit
  - Trip out of hole and lay down rods, pump and production tubing
  - Remove wellhead
  - Secure well with 4 1/2" X 2" swage and ball valve
  - Move rig out
- March 14, 2012:
  - Rig up cementing company to well
  - Establish pump in rate of 2.75bpm at 400psi
  - Mix 30sx lead cement with 2%CaCl2, 1/4#/sx cellophane, 3#/sx gilsonite followed by 89sx Class B cement with 2% CaCl2 all mixed to 15.6 ppg to pressure up to 750psi.
  - Shut in with pressure overnight. Cement fell to 65'
- April 25, 2012:
  - Tag cement at 65' with 1" polypipe
  - Cement from 65 to surface with 14sx Class B cement mixed at 15.6 ppg
  - Install marker
