Cement with 225 sks Class B, 2% CaCl2, 1/4#/sk floccle (266 cu.ft.). Plug down @ 12:15 pm on 04/05/05. Circulate 10 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
