


## Rincon Unit Com 203N

Section 22, T27N, R07W, Rio Arriba County, NM



Drill ground bed approximately 150' southeast of #203N wellhead at staked location. Install rectifier at staked location and connect to UGAC approximately 180' southwest of rectifier (this will require crossing an Enterprise pipeline and an oilfield road). Connect rectifier to ground bed and #203N wellhead at lengths below.

Positive: 195'
