4-14-05 TIH & set RBP @ 5,050'. Attempted to pressure test casing to 500 psig. Casing failed pressure test. Ran GR/CCL/CBL log fr/5,050' to surf. TOC @ 4,120'. Isolated casing leak from 260 to 290'.

4/15/05 Set RBP @ 350'. TIH with 7-5/8" packer & set @ 260. Pumped into leak @ 02 BPM & 1,150 psig. Pressure bled down fr 1,150 psig to 0 psig in 30 seconds. No cicr out breadenhead valve. Notified Steve Mason w/BLM @ 2:10 pm. and Charlie Perrin with NMOC @ 2:24 pm. Both BLM and NMOC approved shooting 2 squeeze holes @ 300' and circulating cement to surface.
