The Tsah Tsah 12 #1 is currently shut-in due to low productivity. Caerus Southern Rockies LLC had planned to restore it's production by utilizing a "Caol Stim" process. Current economics can not justify that project at this time. Because Caerus still believes this is a viable project, Caerus Southern Rockies LLC requests that this well be allowed to remain shut-in for 1 year. A braden head test was recently performed in accordance with New Mexico Oil Conservation Division indicated no communication with the production casing.
