Tail w/100 sx (118 cf) standard cmt w/2% Cacl2, 0.25#/sx flocele mixed @ 15.6 ppg & 5.2 gal/sx w/yeild of 1.18 cf/sx. Circ. 27 bbls cmt to pit. Pressure test csg to 500 psi for 15 min. OK.
