PLUG 1) Set 4 1/2" cement retainer @ 5141'. Pumped 103 sks of cement under retainer and 15 sks on top of retainer. PLUG 2) Set a cement plug from 4113' to 3901'. Pumped 37 sks of cement. PLUG 3) Set plug from 3400' to 3250'. Pumped 27 sks of cement. PLUG 4, 5, & 6) Set plug from 2598' to 2019'. Pumped 99 sks of cement. PLUG 7) Shot 4 holes @ 906'. Set 7" cement retainer @ 856'. Pumped 14 sks on top of retainer. We were unable to pump cement under retainer. PLUG 8) Set plug from 333' to surface. Pump 166 sks of cement to surface. Topped casing off with cement.
