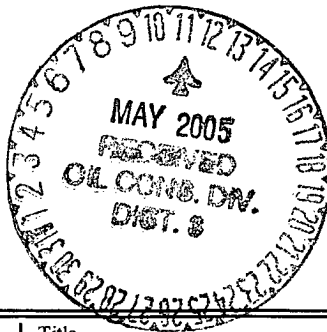

Test casing & BOP to 600 psi - ok.
