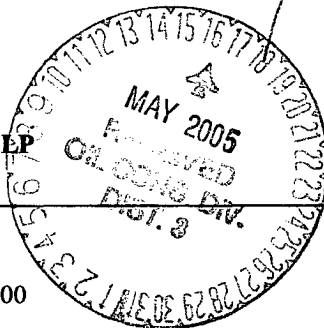

5/5/05 MIRU Mote #1. Spud 8-3/4" hole @ 0900 5/5/05. Drill ahead to 163'. Circ. hole. RIH w/5 jts 9 5/8", 32#, H-40 ST&C casing & set @ 160'. Pumped preflush of 4 bbls H2O, then pumped 50 sx (81 cu - 14 bbls slurry) Type 1-2 Portland cement w/20% flyash & 14.5 ppg into casing. Dropped plug and displaced with 9.6 bbls H2O. Circulated .25 bbls to surface. WOC. Install wellhead. RD & released rig. PT will be conducted by the drilling rig before drilling continues.
