With the warmer weather, we attempted to put this well back to production 5/11/05. Only 5 MCF was produced....not enough to run the pumpjack. Well was shut in. SG plans to replace the pump and try again; however, we are waiting on rig availability. SG anticipates workover around late June, 2005.
