Cemented w/323sxs(688cu-122bbls) scavenger prem lite cement w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4% SMS. Cemented tail w/90sxs(124cu-22bbls) Type 3 cement w/1% CaCl2, .25pps Cell-o-Flake, .2% FL52. Plug down @ 0645hrs 5/12/05. Circulated 18bbls of cmt to reserve pit. RD NDBOP. Rig released 1300hrs. 5/12/05 Will show top of cement & casing PT on next report. PT will be conducted by completing rig.
