Pumped preflush of 10bbls FW, 2 bbls mud, cemented w/9sxs(27cu-5bbls) scavenger cement w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4% SMS, 8% GEL.
