Pumped preflush of 10bbls FW, 10 bbls mud, 10bbls FW. Cemented w/9sxs(27cu-5bbls)scavenger cement w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4%SMS.
