

Tail- 100 sx 5#Gilsonite, 15.2 ppg, 1.27 yield.

Stage 2- (Lead) - 160 sx 65/35 Poz 6% gel/ 5# Gilsonite, 12.4 ppg, 1.87 yield.

Tail - 50 sx 5# Gilsonite, 15.2 ppg, 1.27 yield.

Pressure test Blind rams, Pipe rams, choke manifold, stinger valves, floor valves, and kelly cock to 500 psi for 15 min.

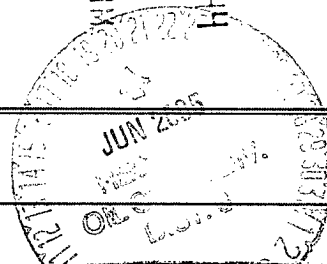
