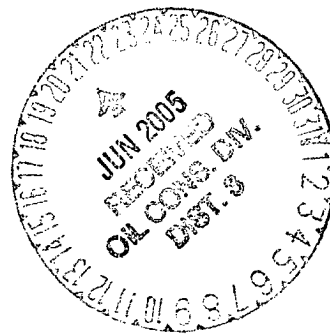

Cement with 225 sks Class B, 2% CaCl2, 1/4#/sk floccle (265 cu.ft.). Plug down @ 9:30 pm on 05/29/05. Circulate 14 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
