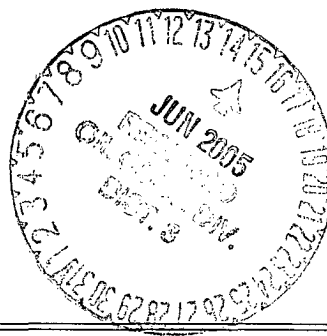

On 3/24/05, set 12 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,700' with 0 sx of cement. Top of liner hanger is at 3,331'. Perforations are from 3,437' - 3,696', 0.49". On 3/24/05 ran back in hole with 122 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,690', return well to sales on 3/25/05.
