5/31/05 MIRU Mote #1. Spud 12 1/4" @ 09:00 5/31/05. Drilling ahead to 163'. Circulate hole. Run 5 jt of 9 5/8" 32# H-40 STC CSG and set @ 160'. RU to cement. Pumped preflush of 4bbls H2O. Pumped 50sx (81cu - 15bbl slurry) Type 1-2 Portland cement w/ 20% fly ash. Drop plug and displace w/ 10bbls H2O. WOC. Tag cement @32' w/ 3/4" pvc. Mix and pump 9sxs (13cu-2bbls) Type 1-2 Portland neat cement to surface. Install wellhead. PT will be conducted by the drilling rig before drilling continues.
