PLUG 2) Unnecessary to pump this plug due to the top of cement being tagged at 4548'. PLUG 3) Shot 4 holes @ 1900'. Set cement retainer @ 1850'. Pumped 35 sks Class B cement below retainer and 5 sks on top. PLUG 4) Shot 4 holes @ 1510'. Set 4 1/2" cement retainer @ 1450'. Pumped 35 sks Class B cement below retainer and 5 sks on top. PLUG 5) Set 7" cement retainer @ 1126'. Pumped 35 sks Class B cement below retainer and 19 sks on top. PLUG 6) Shot 4 holes 844'. Set 7" retainer @ 785'. Pumped 35 sks Class B cement below and 19 sks on top of retainer. PLUG 7) Shot 4 holes @ 264'. Pumped 105 sks Class B cement inside and outside from 264' to surface.
