RIH w/5 1/2" 20# J-55 pre-perf'd liner and set @ 3367' w/ TOL @ 2939' (25 overlap into 7" shoe). Perfs @ (3024'-3045'=21'; 3087'-3214'=127'; 3235'-3300'=65')=213'=426 holes. PU perf mill and milled out perf plugs. Circulate clean. RIH w/106jts 2 3/8" 4.7# J-55 tubing and set @3332' w/SN @ 3306'. ND BOP and NU WH. RU to run rods. 6/10/05 RIH w/rods and pump. Spaced out. PT to 500#, ok. RD and released 6/10/05.
