6/15/05 MIRU Mote #1. Spud 12-1/4" hole @ 0900 hrs 6/15/05. Drilled ahead to 250'. Conditioned hole. RIH w/8 jts of 9-5/8", H-40 32.3# ST&C casing and set @ 247'. Pumped preflush of 20 bbls H2O. Pumped 153sxs(191cu- 34bbls) Type 3 cement w/3% CaCl2. Displaced w/15.5bbls H2O. Circulated 6bbls cement to surface. Cement fell back. Install 1" PVC tag up @60'. Pumped 165sxs(219cu-40bbls) Type 3 cement w/ CaCl2, cement @14.8ppg through 1"PVC. Did not circulate. Pumped 30sxs(42cu-7bbls) Type 1-2 neat cement w/ 20% flyash, cement @ 14.5 ppg to bring to surface. Circulated .25bbls. Installed wellhead. MO 6/19/05. The casing PT will be conducted by the drilling rig before drilling continues.
