Elm Ridge Resources moved a rig onto this location. A bridge plug was set above the existing perforated interval. The casing failure was isolated, squeezed, and pressure tested. Prior to drilling out the bridge plug, two Mesa Verde intervals were perforated tested for production potential. No commercial hydrocarbons were found. The perforations were squeeze cemented and pressure tested. The bridge plug was drilled out, and the well will be returned to production by July 2005. The pump jack needs to be replaced.
