

C/O to TD @ 3713'. Started natural surging well. Then used energized surges with the natural surges for approx. 13 days. 6/1/05 RIH w/6-1/4" bit & drilled sump to new TD @ 3780'. Circ. hole. C/O w/air, foamer & mist. C/O for approx. 5 more days. RIH w/5-1/2", 15.5# K-55 pre-perf'd liner & landed @ 3866' w/TOL @ 3451'. Perfs from 3303' - 3389'; 3432' - 3454'; and 3475' - 3540'; (2 spf - .5" holes = 346 holes). M/O perf plugs. Circ. hole clean. RIH w/2-3/8", 4.7# J-55 tbg and set @ 3721', w/SN @ 3795'.
