SJD Daily Production Graph by Run and Formation

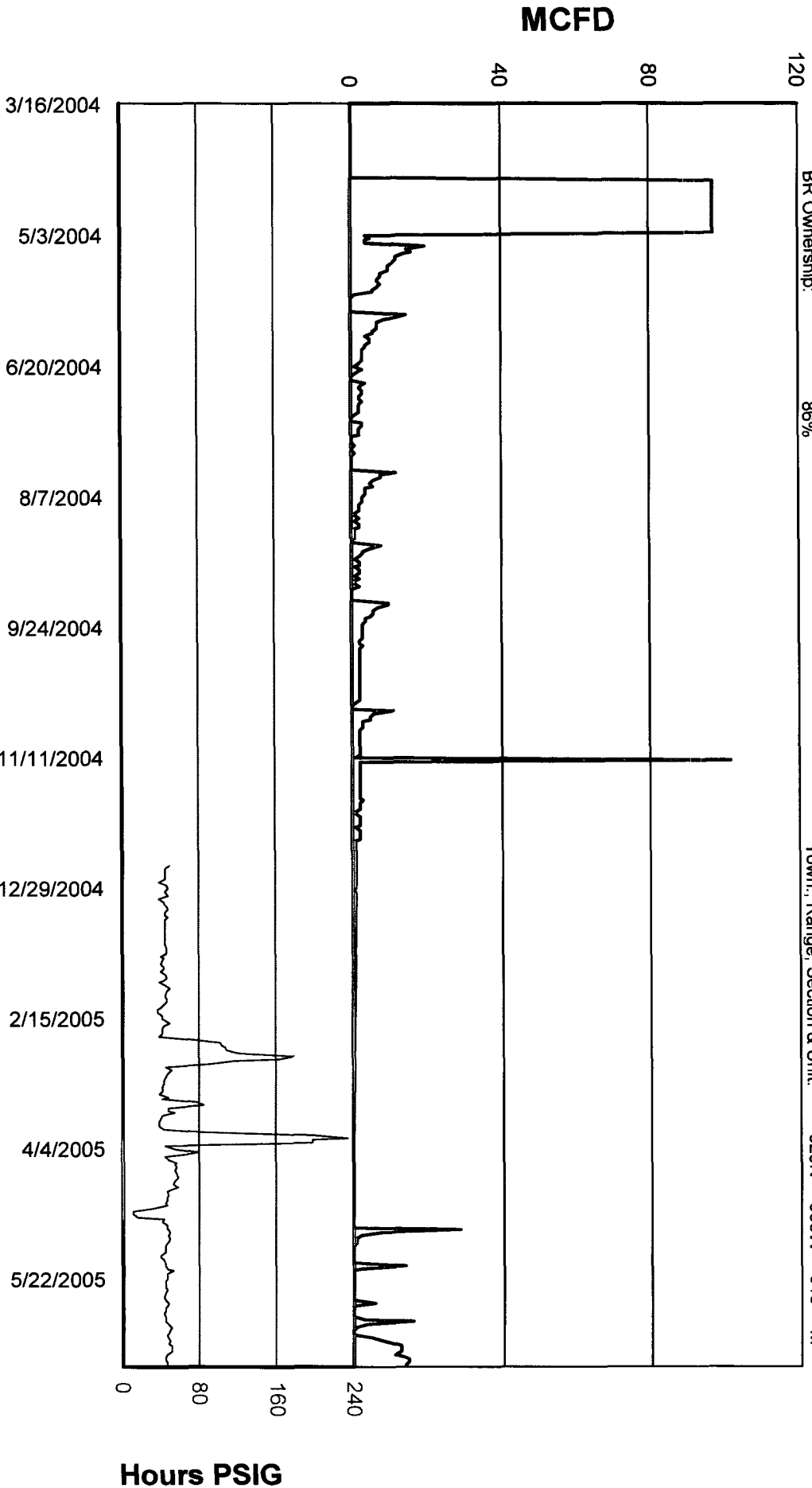
