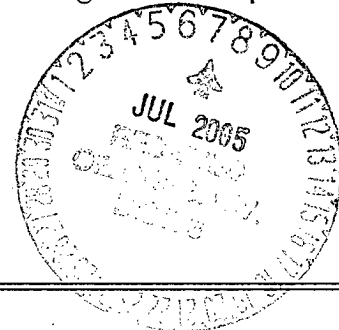
Cavitation/workover started 4/18/2005. Completed 5/6/2005.
