On May 25, 2005, SMA mobilized to the unlined separator pit at the Rincon 263. The dimensions of the unlined pit are approximately 20 X 20 X 4 feet.

On May 25, 2005, SMA collected a soil sample from the center pit bottom for field analysis by Photo Ionization Detector (PID). A four-point composite soil sample was collected from the sidewalls for field analysis by PID. The center pit bottom sample showed a PID reading of 0.7 units and the sidewall composite sample showed a PID reading of 1.0 units. Soil samples for closure were collected for laboratory analysis. Samples were analyzed for Diesel Range Organics (DRO), and Gasoline Range Organics (GRO). Based on Field Screening with a PID, BTEX was not analyzed by laboratory methods. The laboratory analysis of the closure samples showed hydrocarbon levels of:

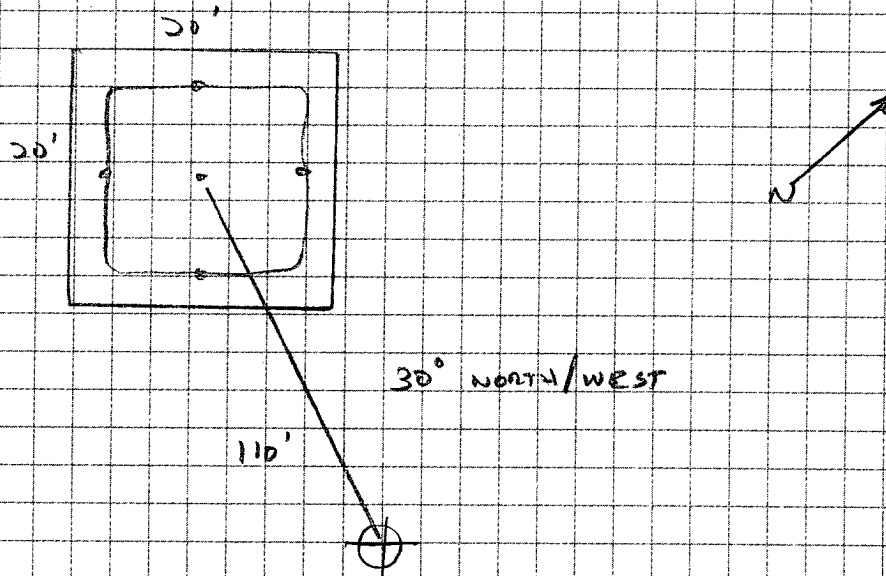

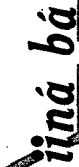
