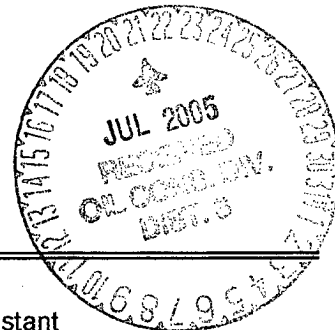

PLUG 2) Perf 4 holes at 1430'. Pumped 11 sks above retainer set plug from 1380' to 1230'. PLUG 3) Perf 4 holes at 144'. Pumped 70 sks of standard cement inside and outside of 4 1/2" casing to surface.
