**Amend Allocation Formula**

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports shall be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 shall be filed once testing has been completed. Final Abandonment Notices shall be filed only after all requirements, including reclamation, have been completed, and the operator has determined that the site is ready for final inspection.

On 02/26/2003, BP filed APD for permit to drill and complete the subject well into the Basin Dakota and Blanco Mesaverde Pools and commingle production downhole. The well was drilled and completed into both zones, however, in order to produce the Dakota a density exception was required. The Dakota formation was isolated (CIBP @ 5400') pending density exception approval. Approval was granted on 09/24/2003. The Dakota, however, has remained isolated - the Mesaverde has continued to produce. It is our intent to drill out the CIBP & commence downhole commingling, however, we do request permission to alter our production allocation method from a fixed percentage to a subtraction method.

Production is proposed to be allocated based on the subtraction method using the projected future decline for production from the Mesaverde. That production shall serve as a base for production subtracted from the total production for the commingled well. The balance of the production will be attributed to the Dakota. Attached is the future production decline estimates for the Mesaverde.
