Operator Lance Oil & Gas Company Inc. respectfully requests the following changes in the Application to Drill on this well.

In the APD approved February 24, 2003, under Item 4, "Casing & Cement", the hole size is indicated as 8-3/4", 7" OD Surface Casing, and 6-1/4" hole, 4-1/2" OD Production Casing. However, to conform to Lance Oil & Gas Company, Inc.'s drilling procedures, operator wishes to drill a 12-1/4" surface casing hole to set 8-5/8" 24# J-55 surface casing, and drill a 7-7/8" hole to set 5-1/2" 15.5# production casing. The cementing volume will be increased accordingly. "Waiting on Cement" time will be as per cementing company recommendation, but will in no event be less than 6 hours.

Therefore, Operator, Lance Oil & Gas Company, Inc. respectfully requests that the APD be amended to drill a 12-1/4" surface hole, set 8-5/8" 24# J-55 surface casing, drill a 7-7/8" production casing hole and set 5-1/2" 15.5# production casing and increase the cement volume accordingly.

No other changes to the original APD are requested at this time.
