RIH w/ 80 jts of 4-1/2" 10.5#, J-55, ST&C casing landed @ 3389'. Circ. & RU BJ, cmnt. w/ 9 bbls of 10/10/10 preflush ahead of lead scavenger cmnt- 9 sx (27 cf - 5 bbls slurry). Then cemented lead w/ 290 sx (617 cf - 110 bbls slurry) Premium Lite w/ 3%CaCl, .25#/sx Cello-Flake, 5 #/sx LCM-1, .4% FI-52, .4% #/sx SMS.
