5. NU ratigan, pumping tee and RIH w/ 2" x 1-1/2" x 12' pump, 3 K BARS, 131-3/4" T Coupling rods, 1-8', 22' polish rod, loaded TBG & tested to 500 PSIG OK. Hand off on head.

Return well to production.
