Drilled 12 1/4" hole to 338' on 5/9/05, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 311'. Cemented w/200 sx (42 bbls) 15.6#, 1.18 Yield cement. Circulated 15 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,765' on 5/13/05, set 88 jts of 7", J-55 LT&C, 23# casing at 3,756'. Cemented lead w/475 sx (123 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (19 bbls) STD, 4/10% Halad 344. Cement top at 940', verbal approval for cement top given by Jim Lavato and Adrienn Brumley.

Drilled 6 1/4" hole to 8,200' on 5/16/05, set 197 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,197'. Cemented lead w/475 sx (124 bbls) 50/50 POZ "B". Cement top at 2,860'. Landed 2 3/8" production tubing at 8,192' on 6/23/05 with 4 1/2 x 2 3/8 Quad-Cup packer @ 3,770' to isolate both zones. Dakota will be producing up tubing and Peitured Cliffs will be producing up the casing. It is not known at this time when or if both zones will be commingled.
