8/5/05 MIRU Mote #1. Spud 12-1/4" surface hole @ 9:00 on 8/5/05. Drill to 162'. Circ hole clean. TOOH. TIH 5 Jts 9-5/8", 32.3#, H-40 Csg set @ 160'. Preflush w/4 bbls FW. Cmt w/59 sxs Type I-II cmt (95 CF-16 bbl slurry) w/20% Fly Ash. Drop plug and displace w/9 bbl water. Circ 1 bbls cmt to surface. RD. WOC. The casing will be PT with the drilling rig before proceeding with drilling.

APD Row Related

- Per discussion with Frances & Ed Jackson on 8/5/05, the stipulation for 200' surface casing was inadvertently missed. This is a violation of CFR 3162.3-2, however a NEW COA is to circulate cement to surface on the next string of casing.
