Drilled 12 1/4" hole to 285' on 7/11/05, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 275'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 750 psi, casing bled from 750 psi to 450 psi in 12 minutes. Received verbal approval from Jim Lavato to continue to drill out, shoe was solid.

Drilled 6 1/4" hole to 3,658' on 7/14/05, set 86 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,648'. Cemented lead w/375 sx (98 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Circulated 10 bbls cement to surface. Landed 2 3/8" production tubing at 3,544'.
