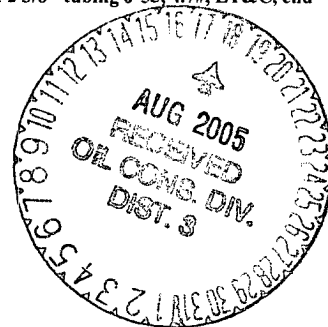

On 7/27/05, set 10 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,472' with 0 sx of cement. Top of liner hanger is at 3,052'. Perforations are from 3,116' - 3,371', 4 SPF, 0.48", 308 holes, 120 degree phasing. On 7/27/05 ran back in hole with 53 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,401', return well to sales on 7/28/05.
