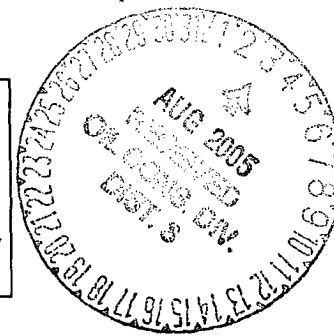

2/05/05 Spud 8 1/4" surface hole. Drilled to 145'. Ran 3 jts. (133.18') of 7" 20#, J-55, ST&C casing and set at 140' KB. Cemented with 50 sx (64 cu.ft.) of Type III with 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 5.0 bbls. of good cement to the surface.

02/06/05 Nipped up the BOP and pressure tested the casing to 600psi.

2/12/05 TD well 6 1/2" hole at 2235' KB. Ran 49 jts (2117.62') of 4 1/2", J-55, 10.5#, ST&C new casing and landed at 2124' KB. Insert float at 2101' KB. Cemented with 235 sx (548 cu.ft.) of Type III 2% SMS cement with 1/4#/sk celloflake and 5#/sk gilsonite, followed by 100 sx (140 cu.ft.) of Type III with 1/4#/sk celloflake, 2% CaCl₂ and 5# sk gilsonite. Bumped plug to 1550 psi. Circulated 26 bbls of good cement to surface.
