6/22/05 - Set CICR at 3552'. Pumped 435 sx Class "B" cement. No inflow into casing above CICR. Max squeeze pressure was 1100 psi.

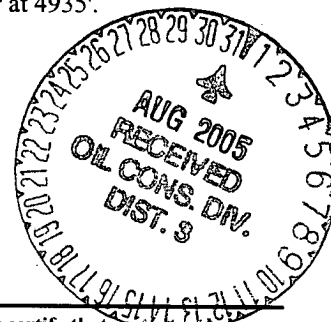
6/23/05 - Drilled out CICR.

7/6/05 - Ran CBL, found TOC at 5080' with cement stringers up to 3650'. Bottom of tubing at 5946' and packer at 4935'.
