Pumped 59sxs (95cu - 17bbls) Type 1-2 Portland cement w/20% fly ash @ 14.5 pps. Drop plug and displaced w/9bbls H2O. Circulated 2bbls. WOC. Install wellhead. Pressure test will be conducted by the drilling rig and will be shown on next report. Rig down and move out.

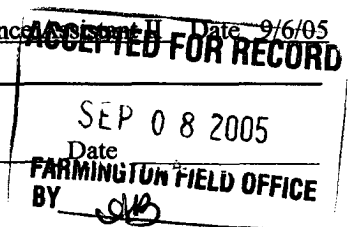
