Spud well at 20:30 hours on September 30, 2012. Drill with 12 1/4" bit to 402' KB. Ran 3 wireline surveys at 94', 215', both 1/4 degree. WLS at 339' was 3/4 degree.

On October 1, 2012, ran 9 jts (379.64') of 9-5/8", 36#, J-55, ST&C casing. Landed casing at 394.24' KB. Circulated casing while rigging up Baker Hughes Cement Services. Preceded cement with 15 bbls of fresh water. Cemented with 160 sks (224 cuft, 1.40 yield, 14.6ppg) of Type III cement with 3% CaCl2, & 1/4 pps celloflake. Dropped top rubber plug and displaced with 28 bbls of water. Plug down at 10:30 hours on 10/01/12. Returned 17 bbls of cement slurry to surface.

Removed landing joint, installed csg nipple & NU wellhead, BOP, Choke manifold & lines.
