Set surface casing string 11/9/12. Gelled freshwater system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0' to 511'. Casing set from surface to 504' TVD/MD.

On 11/9/12 pumped 300 sks Type III Cement + 25#/sk Celloflake + 1% CaCl2 + 0.2% FL52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 35 bbls circ to surface. WOC 12 hours for surface casing.

Float collar at 461'. TOC at surface and BOC at 504'.

Tested BOP and casing 11/10/12. BOP pressure held to 3000# for 30 minutes. No pressure drop. Tested casing to 1500# for 30 minutes. No pressure drop.

Started drilling out cement at 453'TVD/MD on 11/11/12.
