Hole diameter: 8.5", casing diameter: 7", casing weight and grade 26# J55 LTC. Depth of 8.5" hole from 0 to 5875' MD. Intermediate casing set from surface to 5768' MD. Stage tool at 1769'. Top of float collar at 5721' MD. TOC at surface and BOC at 5768' MD.

Stage 1 Cement (Pumped 12/16/12): Lead 351 sks Premium Lite FM + 3% CaCl₂ + 0.25/sk Cello Flake + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate. Mixed at 12.1 ppg. Yield 2.13 cuft/sk. Tail 220 Type III Cement + 1% CaCl₂ + 0.25#/sk Cello Flake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. Circulate 20 bbls to surface. WOC 8 hrs.
